### HIGHWAYS ACT

Pursuant to subsections 14(1) and (4) of the Highways Act, the Minister of Highways and Public Works orders

1. The Haines Road (Highway #3) is closed to traffic between kilometre 71.3 (near Pleasant Camp) and kilometre 193 (Dezadeash Lodge) on January 21, 2017, from 8:00 a.m. to 4:00 p.m. (Yukon time) for the purposes of the Alcan 200 Snowmobile Road Race.
